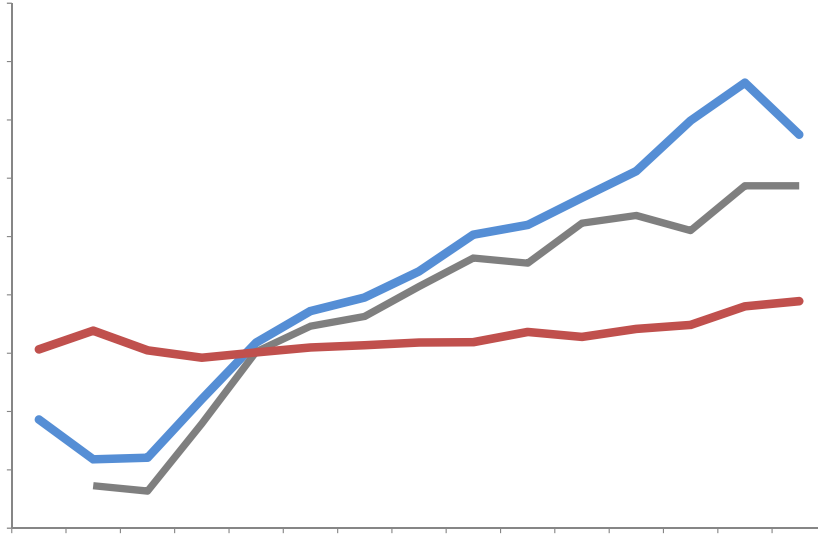

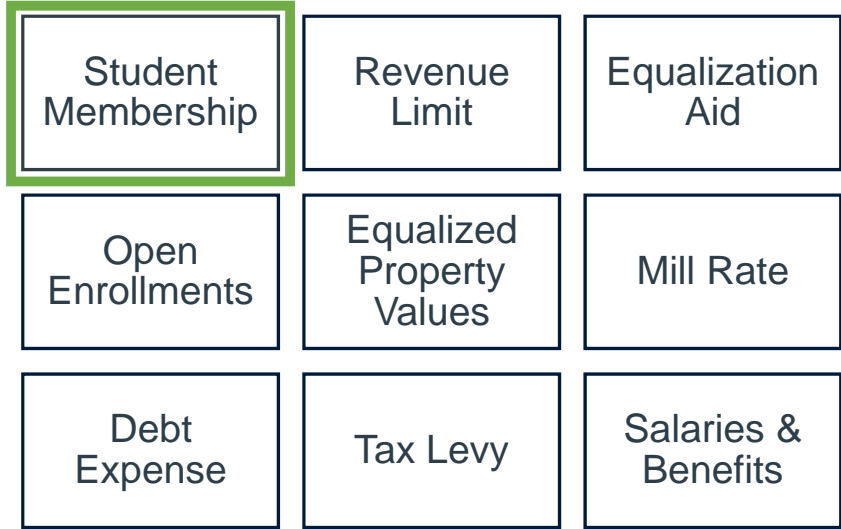

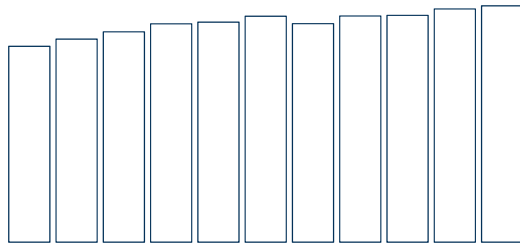
- Allowable Per Member (Student) Change

 - 2024-25 = \$325

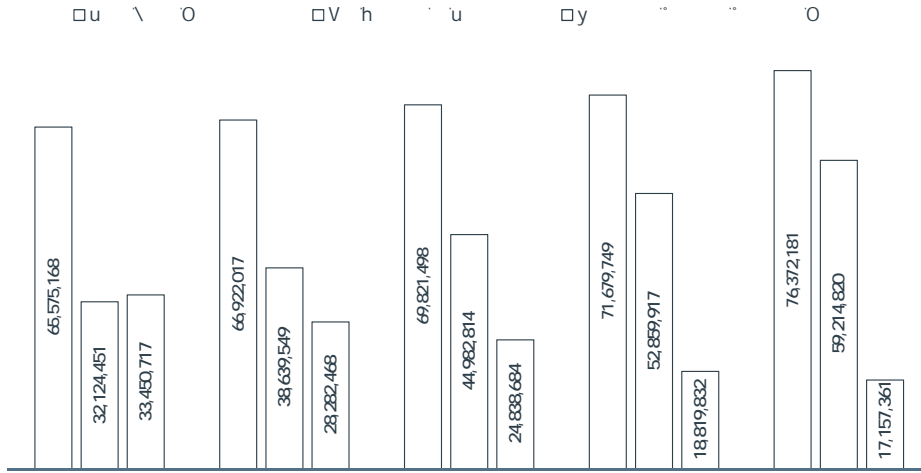
- Per Pupil Categorical Aid (PPCA) \$742 per member

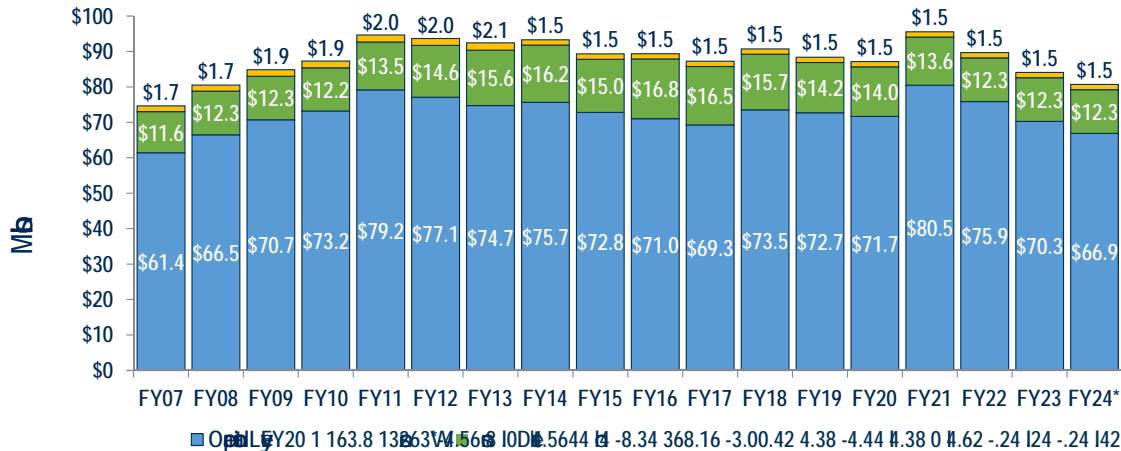
Community Service Funds (Fund 80)
